The instructions related to the entry of Tourists (D. Tourists- D1, D2, D3, D4 and D5), issued through the order No. 625/ USDMA/ 792 (2020) Dated 19th September 2020, is hereby modified as given below.

D: Tourists

- D.1. For the tourist coming to Uttarakhand by all modes of transportation, a registration is MANDATORY on the Smart City web portal http://smartcitydehradun.uk.gov.in prior to their travel.
- D.2. Requirement of mandatory stay of minimum two days in hotel/homestay will not be applicable anymore.
- D.3. It is not mandatory for the tourist to bring Covid-negative test report before check-in in hotel/ homestay. However, checks like thermal scanning, sanitization and other prescribed health protocols for hotels and restaurants must be complied with. If so required, the hotel management may frame their own procedure for tourists coming to their hotel.
- D.4. If any tourist is found Covid positive then the hotel management shall intimate the District Administration immediately. District Administration shall make an arrangement for random checks to ensure that compliance of MHA and MoHFW, GoI guidelines by the Hotel Management/ Homestay owners.

This order supersedes the order No. 625/ USDMA/ 792 (2020) Dated 19th September 2020, with respect to the directions related to the Tourists (D. Tourists-D1, D2, D3, D4 and D5) only, rest of the directions in the above order, shall remain in force till further orders.

This order shall come into force from 23rd September 2020.
